All funds received in response to this solicitation are subject to federal contribution limits and prohibitions. Contributions from corporations, foreign nationals without "green cards," labor unions, national banks, federal government contractors, and any other federally impermissible source are prohibited. The NRCC is a national party committee and consists of three (3) accounts, each with separate, annual, individual contribution limits: (1) a General Account, \$33,900; (2) a Building Fund, \$101,700; and (3) a Legal Proceedings Fund, \$101,700. Unless you provide alternative, written instructions, your signature (and your spouse's signature, if applicable) shall designate your contribution to each NRCC account in the order described above, up to the maximum lawful amount for each account, and joint contributions shall be attributed equally to each spouse.
